# The Five-Year State Plan



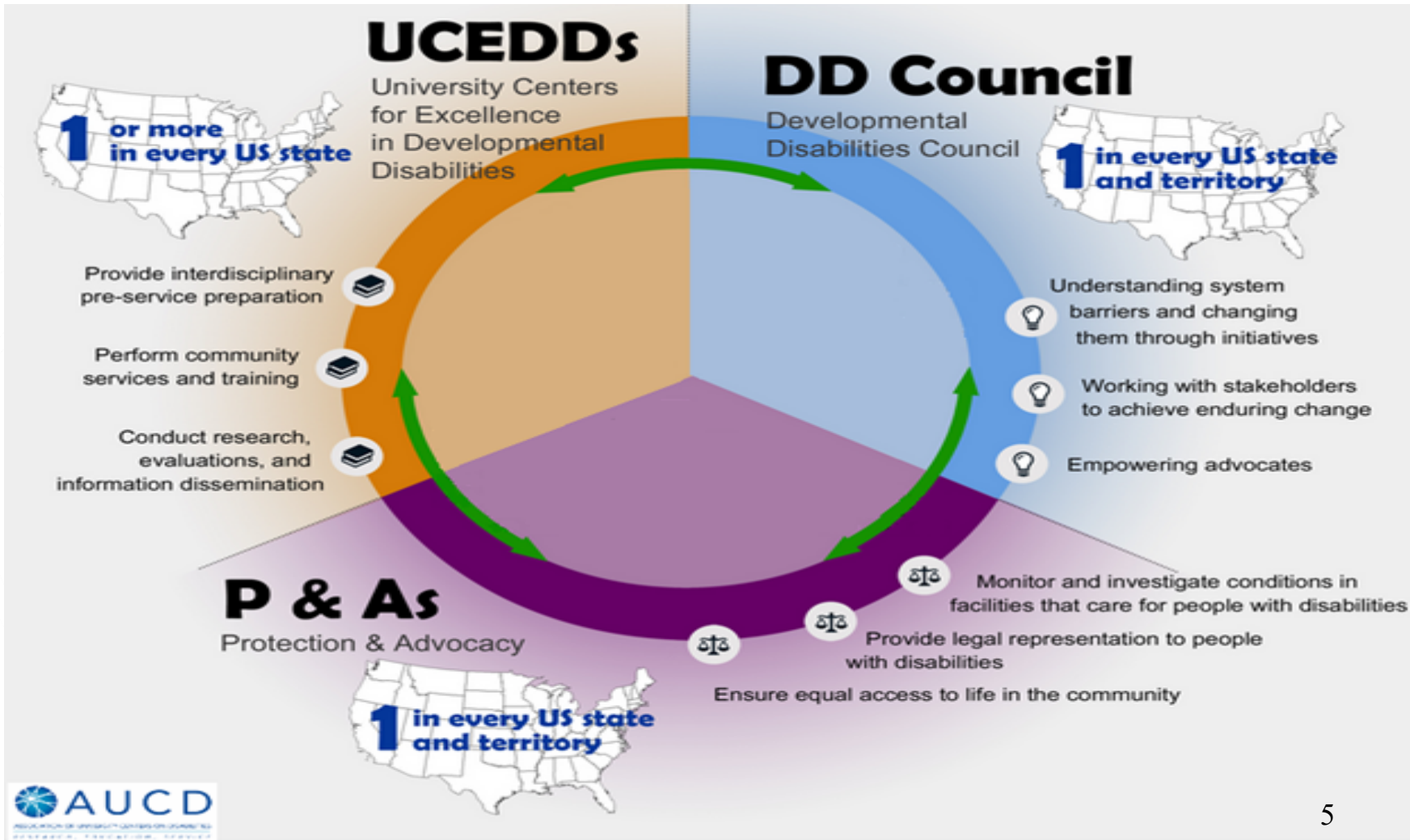
Every five years, the North Carolina Council on Developmental Disabilities develops a State Plan that reflects a comprehensive review of major service systems and issues as they affect children, teens, and adults with intellectual and/or developmental disabilities (I/DD) and their families in North Carolina.

The State Plan is developed in accordance with the Developmental Disabilities and Bill of Rights Act of 2000 (DD Act). The Council's work centers around systems change activities.

Right now, the NCCDD is in the process of developing its Five-Year State Plan (5YSP) for the period from October 1, 2022 through September 30, 2026. The NCCDD will submit its 5YSP to ACL on or before August 15, 2021.

# The DD Act: Expectations for all Councils

**Ensure that people with intellectual or other developmental disabilities (I/DD) and their families participate in the design of and have access to individualized services and supports that are responsive.**

**Engage in education, advocacy, capacity building and system change activities that contribute to a coordinated, consumer and family-centered comprehensive system of community services and individualized supports.**

  - Evaluates efforts of initiatives
  - Insures the plan and efforts are responsive to North Carolinians


